- Nomination papers must be delivered to the Returning Officer, Town Hall, Victoria Square, St Helens, Merseyside, WA10 1HP on any day after the date of this notice (excluding bank holidays) but no later than **4:00pm on Thursday, 9 April 2026**. Arrangements to deliver nomination papers must be by appointment.
- If any election is contested the poll will take place on **Thursday, 7 May 2026**.
- Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Monday 20 April 2026. Applications can be made online: www.gov.uk/register-to-vote.
- Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Town Hall, Victoria Square, St Helens, Merseyside, WA10 1HP by **5:00pm on Tuesday, 21 April 2026**. Applications can be made online: www.gov.uk/apply-postal-vote
- Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by **5:00pm. on Tuesday, 28 April 2026**. Applications can be made online: www.gov.uk/apply-for-photo-id-voter-authority-certificate
- New applications to vote by proxy at this election must reach the Electoral Registration Officer at Town Hall, Victoria Square, St Helens, Merseyside, WA10 1HP by **5:00pm on Tuesday, 28 April 2026**.
- Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Town Hall, Victoria Square, St Helens, Merseyside, WA10 1HP by **5:00pm on Thursday, 7 May 2026**. The physical incapacity must have occurred after 5:00pm on Tuesday, 28 April 2026. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5:00pm on Tuesday, 28 April 2026.
