These conditions are in place not to restrict the choice of individuals, but to ensure the Council maintains control of the appearance and standards within the Crematorium and Cemetery grounds and to ensure every leaseholder is treated in a fair and equal manner.

- No unauthorised plaques, flower containers, memorabilia, Items of personalisation are to be placed on or around the tree base.
- Any Items placed on the tree will be moved and disposed of without prior notice.
- The Council will accept no liability for the plaque as a result of damage or theft and is under no obligation to replace the plaque should these circumstances arise.
- The Council will accept responsibility for the tree's care and attention including free replacement if necessary during the lease period.
- At the end of the lease period a renewal notice will be sent to the last registered address of the leaseholder who may renew the lease on payment of a renewal fee. It is important to notify the Cemetery and Crematorium Office of any change of address.
