Terms & Conditions

These conditions are in place not to restrict the choice of individuals, but to ensure the Council maintains control of the appearance and standards within the Cemetery grounds and to ensure every lease holder is treated in a fair and equal manner.

- No unauthorised plaques, flower containers, memorabilia, Items of personalisation to be placed upon the vault or within the garden areas.
- Any Items placed upon the vault will be moved and disposed of without prior notice.
- The Council cannot accept liability for loss of, or damage to, any memorial, floral tribute or other article, which may be fixed or placed within the vault garden area.
- The Council will notify the leaseholder of any maintenance work needed to maintain the vault and will include the
 cost of the maintenance.
- Floral tributes may only be placed in the flower container at the base of the vault.
- At the end of the lease period a renewal notice will be sent to the last registered address of the leaseholder who
 may renew the lease on payment of a renewal fee. It is important to notify the Cemetery and Crematorium Office
 of any change of address.
- The first opening of the vault and up to 80 letters of inscription is included in the initial lease purchase price.

An additional Interment fee will be charged at the time of any further Interment.
